# IMPORTANT NOTICE

Dear All,

After receiving and discussing with IWWF the feedback received from participants, it has become evident that there is significant concern regarding the inclusion of the Final Party in the entry fee. Many individuals expressed discomfort with paying for an event they may not attend and which increases the Entry Fee significantly, leading to a consensus that the entry fee structure should be revised and we should go back to the original bid.

As a result the entry fee for the 2024 BOTASKI IWWF +35 World Championships will be reduced from €400,00 to €350,00 and the Final Party will no longer be included in the entry fee but will be sold separately to those who wish to attend. This adjustment aims to ensure fairness and flexibility for all participants, allowing individuals to choose whether they want to partake in the Final Party.

The Bulletins will provide detailed information about the revised entry fee structure and the separate sale of Final Party tickets. We are committed to ensuring clear communication and transparency throughout this process to minimize any confusion or inconvenience for participants.

Thank you for your understanding and cooperation in implementing these adjustments. We believe that this revised approach will better accommodate the preferences and needs of our participants while maintaining the integrity and spirit of the 2024 IWWF +35 World Championships.

# 6. IWWF LICENCE

IWWF Waterski Rules 2023 - Rule 1.10

Athletes wishing to compete in 2024 IWWF World Over 35 Waterski Championships are required to hold an IWWF License. It is requested that Federations ensure that all their athletes hold a valid IWWF License.

# 7. ENTRY AND ADMINISTRATION

IWWF Waterski Rules 2023 – Rule 14.12

# Intention to Enter (ITE)

Each Federation shall certify to the Chairman of the World Waterski Council and to the organizing committee, not later than 90 days before the scheduled start of the first event of the World Championships, its intent to compete using this link: <a href="http://www.iwsftournament.com/WorldAdmin/">http://www.iwsftournament.com/WorldAdmin/</a>.

Any Federation not meeting this requirement will not be allowed to compete until they pay a fine of US\$200 to the IWWF.















**3ΟΤΛ**SKI 2024

To be accepted, the "Intention to Enter" must be accompanied by a deposit amounting to US\$50 for each athlete entered on the form. (For instance: 3 athletes: 3xUS\$50 = US\$150). This payment must follow the process described below.

Each US\$50 will be deducted from the entry fee to be paid later for each athlete. If a Federation sub-sequently enters less athletes than declared on the ITE, the fee of US\$50 paid at that time is forfeited for each missing athlete. The payment must follow the process described in this Bulletin.

Any Federation may enter up to two more athletes than originally declared on the "Intention to Enter" form with no penalty, and for which the full entry fee is required. If more than two additional athletes participate, then a levy of US\$50 per additional athlete will be payable in addition to the full entry fee.

This does not include those skiers who may additionally qualify through the Weekly Ranking List or Pro Ranking if applicable.

Remitting parties are responsible for ALL bank charges at both ends. Where bank charges have been deducted, Federations/Skiers will be required to make good any shortfall at registration.

The deadline for each Federation to declare, through EMS, the names of the members of its team, the events each will enter, the ratings of each skier, as well as the names of the official reserves is 60 days before the scheduled start of the first event of the World Championships.

An entry is considered complete when the Skier's name is registered in EMS and the full Entry Fee Payment has been received. The entry fee payment must follow the process described below.

Any skier entered as a Wild Card or Individual is also to be considered as a TEAM reserve.

The 60 days deadline does not include those skiers who may additionally qualify through the Weekly or the Pro Ranking, if applicable, for those skiers the following deadline apply:

- 1) The deadline to enter skiers who qualify under the Weekly Ranking is 30 days before the championships.
- 2) The deadline to enter skiers who qualify under the Pro Ranking is 15 days before the championships.

Any Federation not meeting this requirement will not be allowed to compete until the Federation pays a fine to the IWWF Representative at the Championships, of US\$10 per skier per day after the 60 days deadline for each skier not officially entered.

If a skier is not registered on EMS prior to the 48 hours before the start of the first event, the Federation's skier's places in the draw shall be determined by the Chief Judge without reference to their qualifying scores.

2 days before the start of the first event the entry lists shall be closed at noon (12:00) and thereafter the order of competitors entered and paid will be finalized and posted.













The Scorer in consultation with the Chief Judge should post Preliminary Running Orders 7 days preceding the start of events with the orders clearly marked as "Preliminary and subject to change". No change in this order is allowed after noon of the 2 days preceding the start of events except that a team representative may:

- 1) Withdraw a skier from the competition.
- 2) Replace an injured skier with a qualified official reserve from the same team with the authority of the Chief Judge and before the start of the first event, that is, before the first skier taking part in the first event has started,
- 3) The substitute skier shall start first in the series in which he is qualified unless the draw has not yet been completed.

Team or individual athletes not showing up: In the event a team or individual athletes (for whom their Federation has submitted a competition entry), fail to show up for a competition their entry fee shall still be payable in full, unless a valid written excuse is received by 12 noon of 2 days the day before the start of the competition.

A valid excuse may include a sickness certificate or a certificated injury and should be considered and agreed as valid by the IWWF Representative at the Championships

### Registration Of Participants (Waterski Athletes) In Ems

The registration of a skier's participation in EMS has to be done by an EMS Federation Administrator as follows:



























- 1. EMS Federation Administrator has to login to EMS.
- 2. Go to the Competitions menu and set the Competition Code **24IWWF04** and the Country "**ESP**" in the Search Filters.
- 3. Select the Code **24IWWF04** competition "2024 IWWF World Over 35 Waterski Championships".
- 4. Scroll down to the Participations section and click the "New participation" button to register the Athletes.
- 5. Enter the Name of the Athlete in the Search box and click on the loop sign to the right.
- 6. Register the Division in Competition, the Event and the Entry Type.
- 7. Click on the blue "+Add" button and the participant will be registered.

Repeat Steps 5 to 7 for any additional participants.

#### 8. OFFICIAL FAMILIARIZATION

IWWF Waterski Rules 2023 - Rule 14.07

The last three days immediately before the Championships will be reserved and used for Official Familiarization. This will be organized so that each skier who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarization.

Slalom skiers will receive 4 passes or 6 min. whichever is less.

Trick skiers will receive 2 passes or 5 minutes whichever is less.

Jump skier will receive 3 passes or 6 minutes whichever is less.

After closure of the registration 60 days (06-07-2024) before the Championships, each entered competitor in the IWWF Event Management System (EMS) will be allocated Official Familiarization time as specified above.

45 days (21-07-2024) before the scheduled start of the event, the Organiser (in consultation with the Chief Judge, whose decision shall be final) shall announce the Official Familiarization schedule (including the allowed time).

If a Federation does not want to take part in the Official Familiarization, it must notify the Organizers and the Chief Judge as soon as possible.

The order for familiarization will be based on the team results from the previous IWWF World Championships with the last placed team athletes going first, and shall be grouped by event, i.e., slalom familiarization, trick familiarization and jump familiarization (by jump height) will be grouped together. Any athlete whose time has













not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

The Chief Judge shall have the discretion to change the start time of team's familiarization based on extraordinary circumstances.

During the Official Familiarization period, the Chief Judge may allocate any available site familiarization times, but only to skiers who have not already used it or do not have time allocated.

The cost for Official Familiarization will be 30.00 € per set.

Madrid airport is the first Spanish airport in terms of passenger traffic, air cargo and number of operations. It occupies the 5th position in the classification of European airports according to data from the Eurostat Agency, and is the fifteenth in the world for passenger traffic, according to ACI statistics.

It has four passenger terminals, an Executive Terminal, an air cargo center and two main hangar areas, one in the Old Industrial Area, between T3 and T4, and another in the La Muñoza Industrial Area.

Madrid-Barajas has four parallel physical runways two by two: 18L/36R - 18R/36L and 14L/32R - 14R/32L, and a fifth runway, the first to be built, which is used only as a parking lane.

# 24. HOW TO ENTER THE COUNTRY

A proof of identity and a valid travel document is required to enter Spain

Nationals of third States who travel to Spain for stays of up to 90 days (during any period of 180 days) for tourism, business, family visits, medical treatment, study, non-work internships or volunteer activities with a duration not exceeding 3 months, or for other non-gainful activities, must meet the entry conditions established in the Schengen Borders Code.
