Boca Laguna, Chapala, México – November 4 - 7 2021

# **Bulletin #3**

The Mexican Waterski and Wakeboard Federation welcomes all the Federations from the Pan-American Region to take part in the IWWF 2020 Pan Am Championships (U14, U17, U21, Open) which will take place from the 4th to the 7th of November, following the rules and under the supervision of the IWWF Pan-American Region.

The Pan Am Championships is a 2020 event, due to the pandemic it had to be postponed, so the categories should remain as they were last year.

#### Venue

The Championships will take place in Boca Laguna Ski Club, a manmade lake with world class design. Boca Laguna has been host to IWWF under 21 2009 championships, 2011 Pan-American Games, 2012 World Over 35 Championships, 2014 Latin American Championships, 2015 World Waterski Championships and countless Mexican National Tournaments.

The venue is located in Chapala, the biggest natural reservoir in Mexico. It has a length of 1.112 km and a depth of 4 m. The Laguna Ski Club is located about 4.5 km from the town of Chapala just off the Chapala- Mezcala highway, and just 34 km away from Guadalajara's International Airport, and 50 km from downtown Guadalajara.

Chapala and Ajijic are twin towns located on Chapala's shore and are home to one of the largest ex-pat communities in Mexico. This has created a number of boutique hotels, great restaurants and bars, all in a safe atmosphere for international visitors.

#### Intention to Enter

National Teams must submit their "Intent to Enter the Championship" no later than September 7, 2021.

The penalty applied for late submission of Intentions to enter beyond the 7 September deadline amounts to USD \$20.00 per athlete.

**ATTENTION** - The IWWF 2020 Pan Am Waterski Championships (U14, U17, U21, Open) is a 2020 event, so the categories should remain as they were last year.

#### Official Entries

National Teams must submit their nominal entries for the Championship no later than October 27, 2021.

The penalty applied for late submission of Final Entries beyond the 27 October deadline amounts to USD \$20.00 per day per skier.

**ATTENTION** - Athlete registrations must be sent via email to the Chief Scorer at <a href="mailto:maritzaconchag@gmail.com">maritzaconchag@gmail.com</a> and the Organizer at <a href="mailto:alvarolamadrid1@gmail.com">alvarolamadrid1@gmail.com</a>. The email must contain the athletes first and last names and year of birth. According to Pan Am rules, <a href="mailto:one">one</a> U21 athlete can also compete in the Open Category. If this is the case, the athlete must be included 2 times in the list and a second entry fee must be paid.

## **Official Training**

Training will be available with the official tow boat on November 2nd and 3rd at a cost of USD \$300 per hour. (Minimum booking: 30 minutes).

After this date, practice times will be allocated to ensure all countries have equal practicing opportunity according to their request and the number of participants, following the guidance set forth on rule 1.4 of the 2014 IWWF Waterski Rules. The Organizing Committee will inform Federations of their practice time.

It is necessary to register in the EMS system and pay for the training times, because that way the times will be programmed for each country. The deadline to reserve is October 19.

If a VISA is required, the Mexican Waterski and Wakeboard Federation (FEMEW) can provide an invitation letter for the Championships. Alternative, participants can also obtain a letter from their own Federation confirming that they are a member of their country's National Team.

It should be noted that the VISA must be obtained at the Embassy or Consulate of Mexico before the participant leaves their country. We advise that the participant allows plenty of time prior to their expected departure to obtain this document.

## **Doping Control**

In accordance with the IWWF Anti-Doping Rules, doping controls may be conducted during the competition. By entering this competition, all athletes agree to be subject to doping control.
