In general

The Waterski Clubs Halle and Bremerhaven (Germany) organizes together with the German Waterskiand Wakeboard-Federation the Boesch-Slalom-Tour 2021.

The competition is **Ranking list in Slalom** (four rounds), for the categories U10, U12, U14, U17, U21, Open, Senior 35+, 45+, 55+, 65+, 70+, 75+, 80+.

Promotor

The German Waterski & Wakeboard Association promotes the **Boesch-Slalom-Tour** for Slalom.

Participation

Skiers who want to participate in the competition must have a valid license of an association belonging to the DWWV region EA or other regions.

The tournament will be carried out in the following groups: U12-U14, U17-U21, Open, Senior 35+, 45+, 55+, 65+, 70+, 75+, 80+.

<u>Rules</u>

The tournament is carried out according to the rules of the DWWV as well as the additional rules of the DWWV Region Europe.

<u>Entry</u>

The participants must apply through EMS (Event Management System by DWWV, <u>https://ems.DWWV.sport/</u>) only. Listed participants will receive a confirmation. The latest day of entry is:

(the Organizers) accepting my application, and permitting me, to participate and compete in the **BOESCH SLALOM TOUR 2021** (the Competitions), I, the undersigned, for and behalf of myself, my heirs, executors and administrators, do hereby irrevocably and unconditionally warrant, represent and undertake to the DWWV and the Organizers as follows:

- Any and all information provided and/or disclosed by, or on behalf of, myself to the DWWV and the Organizers (including any directors, officers, employees, volunteer, and other representatives thereof) for the purpose of considering and evaluating my application for participation and competition in the Competitions is true, correct, and accurate.
